Plan applies to clear plastic retainer replacement. Hawley retainers and retainers with pontic (fake tooth) do not apply and will be repaired or replaced at the current pricing. 5 years begin from the date braces/aligners are removed or from enrollment date listed on the form above (whichever is later). Payment is due the day the scan is taken. For a lost or broken retainer, notify us within 24 hours to ensure teeth do not shift (takes 5-7 days to receive new retainers). Inform the Davis & Goldberg Team when scheduling that you have the Peace of Mind Retainer Plan. If payment plan is selected, treatment is completed and patient defaults on agreed upon payments, contract is void until full treatment and Peace of Mind Retainer Plan payments are made in full.
